In exchange for participating in the activities and events of the Club and, also in exchange for being permitted to operate UTV's upon designated trails and areas located on public or private property of landowners whose permission has been obtained by the Club, I/we understand and agree as follows:

Acknowledgement and Assumption of Risk: I/we understand and acknowledge the risk of accident or injury to my/our person and/or property and to others while riding UTV's. I/we accept and assume all risks and dangers and all responsibility for any such accident or injury no matter how, or by whom, it may be caused.

Release, Waiver, Hold-Harmless and Indemnity: To the fullest extent permissible by law, I/we hereby release, waive, discharge, and covenant not to sue the Club, or the landowners, from all liability, and further agree to indemnify and hold them harmless for accident or injury whether caused by the negligence of the Club, the landowners, or otherwise.

I/WE HAVE READ THIS ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY, HOLD-HARMLESS AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I/WE MAY HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT, ON BEHALF OF MYSELF/OURSELVES AND MY MINOR CHILDREN, FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME/US AND FULLY INTEND MY/OUR SIGNATURE TO BE A COMPLETE, CONTINUING AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE FULLEST EXTENT ALLOWED BY LAW.

MEMBER CODE OF ETHICS

Club Members will be respectful towards other members, members of other clubs, club sponsors, invited guests, and those we meet during club activities. The Board of Directors asks that you report any issues so that they may be rectified immediately.

I/we recognize that people will judge all motorized trail users by my actions.

I/we will ride only on designated signed or mapped trails and areas.

I/we will slow down, use caution and be courteous when I/we encounter other trail users.

I/we will respect and preserve the public and private property that I/we ride on.

I/we will ensure my equipment meets Idaho State safety codes (insurance, registration, emission, etc.).

I/we will not endanger myself and other trail users by riding beyond my ability or while impaired by drugs or alcohol.

I/we will not construct jumps or obstacles anywhere on the trail or riding areas.

I/we will not attempt to disturb or directly pursue wildlife with my recreation vehicle.

Note: Club membership may be terminated at any time by a vote of the Board of Directors. Just cause for termination includes, but is not limited to, failure to abide by the "Member Code of Ethics".
